ADJUDICATION ORDER 2014-04-05

Dear Mr. Cavell:

The Accountancy Board of Ohio (Board) conducted a formal disciplinary hearing on April 25, 2014 at 12:55 p.m. The purpose of the hearing was to determine what action should be taken against you for violation of Ohio Revised Code Section 4701.16(A)(9) and (11) for the failure of a public accounting firm to obtain a firm registration; and for failure of a public accounting firm to comply with section 4701.04 of the Revised Code concerning firm registration.

Our records indicate that you requested a hearing in a timely manner and that you were present at that hearing. Section 4701.16(B) of the Revised Code provides that the Board may take action against your CPA certificate for violation of division 4701.16(A)(9) and (11). The Board members present voted 8-0 to revoke your CPA certificate and firm registration, but to stay the revocation subject to submission of: a \$3,000 fine, firm registration renewal forms and related late fees (\$330.00), a final acceptance letter of a completed peer review, and proof of completion of a Board approved Professional Standards and Responsibilities (PSR) course, by July 31, 2014.

TIME AND METHOD TO PERFECT AN APPEAL

Any party desiring to appeal this Order shall file a Notice of Appeal with the Accountancy Board of Ohio, 77 South High Street, Columbus, Ohio 43215-6128, setting forth the order appealed from and stating that the agency's order is not supported by reliable, probative, and substantial evidence and is not in accordance with law. The notice of appeal may, but need not, set forth the specific grounds of the party's appeal beyond the statement that the agency's order is not supported by reliable, probative, and substantial evidence and is not in accordance with law. The Notice of Appeal shall also be filed by the appellant with the (appropriate court of common pleas). Such notices of appeal shall be filed within fifteen (15) days after the mailing of the notice of the Accountancy Board of Ohio's Order as provided in Section 119.12 of the Ohio Revised Code.

A copy of your notice of appeal must also be timely filed with the Court of Common Pleas of the appropriate county pursuant to the following provisions of Section 119.12 of the Ohio Revised Code:

Any party adversely affected by any order of an agency issued pursuant to an adjudication...denying the issuance or renewal of a license or registration of a licensee, or revoking or suspending a license...may appeal from the order of the agency to the

court of common pleas of the county in which the place of business of the licensee is located or the county in which the licensee is a resident... If any party appealing from the order is not a resident of and has no place of business in this state, the party may appeal to the court of common pleas of Franklin County. Any party adversely affected by any order of an agency issued pursuant to any other adjudication may appeal to the court of common pleas of Franklin County...

You must determine the appropriate court in which to file your notice of appeal in light of the action taken by the Board. You may wish to obtain legal advice in making this decision.


Simply filing a notice of appeal will not prevent this adjudication order from taking effect. If you wish to stay the effect of the adjudication order pending the outcome of the appeal, you must: apply for and receive a stay order from the court of common pleas in which you filed your notice of appeal pursuant to Section 119.12 of the Ohio Revised Code.
